**EX PARTE RESTRAINING ORDER**


**ORDER ENJOINING REMOVAL OF LIFE SUPPORT FROM  
STEFFEN RIVENBURG, JR.**


This cause came on to be heard on the 30<sup>th</sup> day of May, 2017 upon the Ex Parte Petition of PATRICIA TORNBURG, mother of STEFFEN RIVENBURG, JR., to enjoin the medical staff at Vanderbilt Hospital and the Department of Children's Services from the removal of life support from her child, STEFFEN RIVENBURG, JR.

1. The Mother asserts that her parental rights are not being considered as she has voiced her objection to the removal of life support for STEFFEN RIVENBURG, JR., and her objections are being ignored by the medical staff at Vanderbilt Medical Center and by the Department of Children's Services.
2. The Mother asserts that her parental rights have not been terminated and that she still has the right to make such major life and death decisions for her child.
3. The Court hereby enjoins removal of life support for the minor child, STEFFAN RIVENBURG, JR., until such time as the Mother has given her consent to such.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED, that life support for STEFFAN RIVENBURG, JR. shall continue until such time as the Mother, PATRICIA TORNBERG has given her consent to the removal of same. *But not later than June 6, 2017 at Noon.*


