23 The court orders as follows

- 24
25 1) That a Temporary Restraining Order be issued precluding Respondents from
26 performing any apnea tests on Alex Pierce be issued;

- 1 2) That an Order be issued precluding Respondents from removing Alex Pierce from
2 respiratory support, or removing or withholding medical treatment;
3
4 3) That an Order be issued that Respondents are to provide Alex Pierce treatment to
5 maintain his optimum physical health, including but not limited to nutrition and
6 thyroid hormone as needed, in such a manner so as to not interfere with the
7 neurological testing (such as the use of sedatives or paralytics in such a manner and/or
8 at such time that they may interfere with the accuracy of the results).

10 4) That an Order be issued that Petitioner is entitled to an independent neurological
11 examination, with the assistance of Loma Linda University Medical Center's
12 diagnostic equipment and technicians necessary to carry out a repeat EEG and a
13 Cerebral Blood Flow Study.
