**ORDER AFTER DECEMBER 29, 2015 HEARING ON PRIME'S MOTION FOR ORDER
TO SHOW CAUSE AND OTHER NOTICED INTERIM ISSUES**

This matter came before the Court on December 29, 2015 for hearing on Prime Healthcare Services, LLC dba Saint Mary's Regional Medical Center's ("Saint Mary's") motion for order to show cause and other noticed interim issues. Saint Mary's filed its motion on November 25,

1 2015, Petitioner/Guardian Gebreyes filed an opposition on December 11, 2015, Saint Mary's
2 replied on December 16, 2015. Present at the hearing were Petitioner/Guardian Mr. Fanuel
3 Gebreyes ("Mr. Gebreyes"), by and through his attorney, David O'Mara, and William Peterson
4 and Janine Prupas representing Saint Mary's. Saint Mary's presented evidence through exhibits
5 and testimony by Dr. Aaron Heide to support its motion for order to show cause.

6 Having considered the motion for order to show cause, opposition and reply, and all other
7 papers and pleadings on file in this action, and all testimony, exhibits, and arguments of counsel,
8 that Court makes the following findings and issues the following Order:

9 FINDINGS:

- 10 1. Ms. Aden Hailu remains under the care of Saint Mary's Hospital in Reno, Nevada.
- 11 2. Mr. Gebreyes is the Guardian of Ms. Hailu and has authority pursuant to NRS
12 159.079 to authorize medical treatment; approval of the Court is only required before the
13 Guardian may consent to certain treatment consistent with the provisions of NRS 159.0805.
- 14 3. The Remittitur from the Nevada Supreme Court was issued on December 22,
15 2015.

16 IT IS HEREBY ORDERED:

- 17 1. Pursuant to Nev. R. Civ. P. 35 and in conformance therewith, and pursuant to its
18 request in the motion for order to show cause, Saint Mary's is allowed to conduct two (2)
19 electroencephalograms ("EEGs") and any and all clinical neurological tests (save and except an
20 ocular vestibular test as further explained below) on Ms. Hailu prior to January 22, 2016.
- 21 2. Petitioner/Guardian has five (5) days to file any objection related to Saint Mary's
22 conducting an ocular vestibular test and CT scan. Saint Mary's has five (5) days after the
23 objection is filed to file a reply. Thereafter, the Court will issue a decision whether Saint Mary's
24 is allowed to conduct the ocular vestibular test and CT scan prior to January 22, 2016.
- 25 3. The parties are granted leave to open discovery; production of the medical records
26 should be ongoing. Discovery cut off is one week prior to the January 22, 2016 hearing. All
27 expert witness credentials and written reports will be exchanged at that time absent agreement of
28 the parties.

5. A hearing on the Nevada Supreme Court Remand Order of November 16, 2015 is set for January 22, 2016 at 9:00 a.m. (all day).
