We would like to invite you to participate in the 7th Annual Health Law Regulatory & Compliance Competition, which is being held on Saturday, February 17, 2018, from approximately 8:00 a.m. until 3:00 p.m. at the University of Maryland Francis King Carey School of Law in Baltimore, MD. There is no cost to enter the competition, however, teams must cover expenses associated with travel and lodging. Breakfast and lunch, along with light refreshments will be served the day of the competition.

### About the Competition:

The Competition requires teams of 2-3 students to analyze a hypothetical fact pattern involving various interactions between health care stakeholders and entities participating in several health care activities that necessitate regulatory and compliance oversight. The fact pattern will be given to teams the day of the completion, and students will have approximately 1.5 hours to analyze the problem. Teams will then present their findings and recommendations to a panel of practicing regulatory and compliance attorneys. The winner will be announced at the Competition during the celebratory competition luncheon.

The 7<sup>th</sup> Annual Competition will focus on several interactions between various health care stakeholders, including rural community hospitals, academic medical centers, physicians, private medical practices and related third parties. Specifically, this year's problem will challenge students to address several areas, including but not limited to:

Healthcare fraud and abuse issues, including the Anti-Kickback Statute and applicable safe harbors and exceptions, Stark Law, Civil Money Penalties Act, and the False Claims Act

Hospital related issues including credentialing of health professionals, Medicare Conditions of Participation and Conditions for Coverage

Challenges associated with telehealth services implementation, payment and reimbursement
